There's No Place Like Rainbow Village

Rainbow Village's reputation for quality long-term homes for people with developmental disabilities is spreading. Creative Concepts for Living (CCL), a support service agency that we have not partnered with in the past, contacted us on behalf of three of their clients who were living in a rented home that was being poorly maintained with a leaking roof, buckling linoleum floors and broken heating and cooling.

Executive Director of CCL Denise Millham-Quirk told us "for the safety of our clients we want to move them into a Rainbow house because we have received great recommendations about the service RBV provides to their homes."



Rainbow to the rescue! We purchased a home in Florissant for the women and renovated it by painting, installing a new electrical service panel, hard-wired smoke and carbon monoxide detectors and remodeling the bathroom. The previous owners built the house to be accessible for their son and wanted the home to be used by others needing accessibility. Two of the new residents are in wheelchairs, so this house is perfect for them.

The women moved in July of this year and are now enjoying a safe and comfortable Rainbow Village home. All three of the women, Candace, Michelle and Christa, work at

Valley Industries. They are happy that they were able to stay in North County where they can be close to work and their favorite social activities.

We were able to provide these residents with a beautiful and safe home thanks to the generous grants received for the down payment and renovation assistance from the Productive Living Board of St. Louis County, the Orthwein Foundation, Boeing Employee Community Fund, the Pott Foundation and the Sander Charitable Trust. Thanks for helping us to realize more dreams as we all know that **home is where the heart is.** 🏠

Meet the Donor

Edith Wolff

This is a new feature to the *Rainbow Connection* newsletter. Each of our donors has a 'story' and we would like to share some with you.

“**Edith Wolff** is a remarkable woman,” said **Jim Fogle**, Rainbow Village board member and long-time friend of Edith and her late husband **Al Wolff**. She is a lifelong St. Louisan, still living in her Clayton home for the last 60 years. Edith’s husband owned the Wolff Construction Company, a pioneer builder of shopping centers, until his death in 1989. After spending years watching her husband run a successful business, Edith Wolff took over the reigns of the company, entering the business world in her 70s. She knew intuitively how to do things as Al did and for the past 19 years it has continued to be very successful under her leadership. Today, Wolff Company focuses on real estate investment and management and leasing shopping centers.

Edith Wolff says, “My husband worked very hard for our money, and I want it to do some good...to help people in need.” Indeed, she is involved in many local organizations that assist medical research and that help people — particularly those with special needs, who are among the most vulnerable citizens in our community.

Recently, Edith Wolff assisted Rainbow Village by being a major donor to our ‘green’ handicapped accessible villa completed in 2006. This award-winning environmentally friendly house is now home to six aging women with developmental disabilities. Her generosity has also provided down payment assistance for Rainbow Village homes recently purchased in Florissant and Mehlville.

We are fortunate to be one of the partners Mrs. Wolff has chosen to receive her charitable gifts. We appreciate her gifts and her faith in Rainbow Village, and we pledge to use her gifts wisely to help provide additional housing for persons with developmental disabilities. 🏠

What Are People Thinking?

Our new look is a direct result of our new outlook. Thank you to all those who participated in our marketing research study. As part of our marketing and public relations initiative, we engaged **Linda Tyler and Associates LLC** to develop and conduct attitudinal research studies with donors, agency partners, potential partners, Rainbow Village families, the Rainbow Village board of directors and staff members and to conduct a community awareness survey targeted to potential donors.

Among the survey findings:

- Awareness of Rainbow Village is less than 10 percent in the communities where our homes are located.
- Residents' families need a clearer understanding of the current responsibilities of Rainbow Village as compared to their support service agency.
- Rainbow Village should focus on corporate outreach and grant programs.

The information we gained from this study has already been used as we develop our marketing and public relations endeavors. 🏠
